Summary:

- Clubs must have met all re-affiliation requirements before the commencement of the AGM.

Action:

- Re-affiliation requirements are due at SLSWA by the 31st August 2008.

Affiliation provides club and members access to national and state lifesaving awards, competitions, meetings and decision making, public liability and personal accident insurance, the use of trademarks and intellectual property.

The following re-affiliation requirements are due at SLSWA by the 31st August 2007.

Clubs wishing to vote at the AGM must have met all re-affiliation requirements before the commencement of the AGM.

For re-affiliation with SLSWA. Clubs are to:

1. Complete the "Application for Affiliation" form (listing Club Delegate) Annexure 1.
2. Payment of Affiliation Fees as per attached schedule – note an SLSWA invoice will be sent to your club.
3. Send an updated copy of the Club Constitution (inclusive of amendments) or written confirmation that no alterations have been made to the club's constitution since last season to SLSWA.
4. Send copies of the Club's Certificate of Currencies for insurances held.

DETERMINING YOUR FOLLOWING YEAR'S AFFILIATION FEE

The assessment criterion for the 2009-2010 season has been simplified to encompass core elements of a club's administration and therefore the differentiation relating to clubs with paid administrators and those without has been disregarded.

To have the following year's Affiliation fee waived a club must obtain an efficiency rate of at least 85 points, any club not meeting this level must pay the full fee of \$750.
