Affiliation with Surf Life Saving Western Australia (SLSWA) provides club and member's access to a range of services and administrative benefits, including national and state lifesaving awards, competitions, meetings and decision making, fundraising and corporate services support, public liability and personal accident insurance, the use of trademarks and intellectual property.

By Affiliating with SLSWA your Club is required to abide by and be subject to the Constitution, By-Laws, Regulations and Resolutions, of SLSWA.

### Note Other Affiliations

(i) SLSA

SLSWA is recognised as the Western Australia State Centre of SLSA and subsequently as part of affiliation with SLSWA, your Surf Life Saving Club Board/Committee should note that your Club will automatically be affiliated with Surf Life Saving Australia. As such your Club is required to abide by and be subject to the Constitution, By-Laws, Regulations and Resolutions, together with the awards and equipment of SLSA (in addition to those of SLSWA) without reservation. This affiliation allows your Club to access SLSA programs, competitions, sponsorships and grants.

The SLSWA Board has determined that the 2018-19 affiliation fee will be waived.

The following SLSWA re-affiliation requirements are to be submitted to SLSWA by **4:00pm Monday 3 September 2018**.

### **For re-affiliation with SLSWA Club's are to:**

1. Complete the "Application for Affiliation" form (listing Club Delegate) Annexure 1,
2. Payment of Affiliation Fees – Not applicable for season 18/19
3. Send an updated copy of the Club Constitution (inclusive of amendments) or include written confirmation that no alterations have been made to the Club's constitution since last season to SLSWA,
4. Send copies of the Club's Certificate of Currencies for insurances held,
5. Send a copy of the Club's Annual Report, and
6. Send of a copy of the Club's audited accounts.
